



## Local Fishing Regulations - Jaderný pond

### **CATCH AND RELEASE fishing**

#### **1. FISHING PERIOD**

- Sport fishing is permitted from 1 April to 31 October for persons who present a valid fishing authorisation for the relevant year issued by Rybářství Hluboká cz. s.r.o.
- **The daily fishing hours are set in the months of April and May from 5 a.m. to 11 p.m.**
- **In the months of June - September it is allowed to fish all day (0 - 24 hours).**

#### **2. FISHING GEAR, FISHING METHODS AND LURES**

- **Fishing is practiced in a CATCH AND RELEASE manner, all caught fish must be carefully returned to the water.**
- Fishing is permitted with two rods, each with one single-hook leader, while no other additional rods may be ready to fish.
- Only continuous - escape assemblies are allowed so that the weight pencil can fall off when the line breaks.
- Fishing for spinner is allowed all season long with only one rod.
- Fishing for live or dead fish, or their parts, is prohibited.
- Fishing of predators is allowed throughout the season and only with an artificial lure with a single hook.
- Every fisherman is obliged to use a bath tub or pool pad under the fish when handling caught fish, a hook extractor, a scoop with arms of at least 80 cm and disinfection intended for fish treatment are mandatory.

#### **What is prohibited:**

- Storing fish in a visor or jacket, the fish must be returned to the water immediately after removing the hook and treatment.
- Use blood as bait.
- Using troll lines.
- Cutting branch forks from growing trees and shrubs and felling of all wood species.
- Fishing from boats and other vessels.
- **Baiting and loading baits and baits, in any way (loading boats are prohibited).**
- **Lighting a fire.**
- **Disturbance of the night-time silence, which is set from 10 p.m. to 5 a.m.**
- Any reservation of fishing spots.
- Fishing with cast net, drop net or landing net.



## 3. FISHING BEHAVIOUR

- Rods may only be handled by a person who has duly purchased a fishing licence.
- When fishing, angling persons must keep a distance of at least 3 m between themselves, and at least 20 m when fishing with a jigging rod, unless otherwise agreed.
- It is forbidden to leave litter on the bank or to throw it into the water. The angling person must clean up the habitats where he/she intends to fish, even if he/she has not caused the pollution.
- **It is forbidden to light a fire on the habitat. It is only allowed to cook in a grill or a safe mobile fire pit.**
- After removing the hook, it is mandatory to treat the damaged area with a suitable disinfectant intended for the treatment of fish.
- Photography of fish is only allowed above the mat or in the water.
- Visitors must not disturb other fishing participants by noisy behaviour.
- Vehicle can only be used to get to the site, the angling person moves on foot during fishing so as not to disturb other anglers.
- **Entry by car to the fishing area (behind the barrier) is only possible for the holder of the permit, other possible escorts park their cars outside the area.**
- **Caravans and other accommodation facilities may only be placed and used for the duration of the permit.**

## 4. CONTROL

- Control and supervision is carried out by the water bailiff, the duly appointed Fishery Guard and the public order authorities.
- The angling person shall present the inspection authority with a fishing authorisation and allow inspection of gear.
- Each angling person must have a valid permit in his/her own name in which to record catches, the permit can be both printed and electronic (**each angling person is responsible for the functionality of the electronic permit and its non-functionality may lead to the withdrawal of the licence**).
- **Entry to the pond area and stay at the habitat is only possible for a person with a valid permit and with a maximum of one accompanying adult person.**
- If the angler has committed an offense against the fishing regulations, altered the fishing authorization in any way, lent it to another person or appropriated the caught fish, the authorization will be taken away without compensation and he must leave the area immediately.
- Appropriation of caught fish will be considered as poaching.
- Every hunter in the area is obliged to allow designated persons carrying out the inspection to check the luggage compartments of the car or residential equipment.

## 5. FINAL PROVISIONS

- **Entrance and parking in the pond area is charged according to the current price list.**
- Rybářství Hluboká cz. s.r.o. is not responsible for any damage or loss of cars, caravans, tools, gear or personal belongings.
